#### Hancock Receives Tax Credits Via Village Designation

The Gathering Inn, located in Hancock's small village, was recently awarded \$12,638 in tax credits through the Vermont Village Designation Program. With hard work from a dedicated team of town planning commissioners and assistance from TRORC, a Town Plan was adopted in November of 2013, paving the way for a longawaited Village Designation in March of this year. All told, there are 21 Designated Villages and 3 Designated Downtowns in the TRORC region. The Gathering Inn is one of four commercial businesses in the TRORC region to receive a total of \$100,000+ in tax credits through the Village and Downtown programs in July.

#### **TRORC** awarded CDBG Disaster Recovery Planning Grant

Tropical Storm Irene damaged a significant portion of Town infrastructure across the TRORC region. During the storm, countless undersized culverts were severely damaged or destroyed, leading to many roads being washed out. TRORC sought funds for a CDBG Disaster Recovery Planning Grant to assist 12 Towns impacted by Tropical Storm Irene with updating culvert inventories over a two year period. The scope of work will include updating GPS locations of culverts, updating culvert attributes (size, condition and material based on state standards), and creating new maps. Culverts will be assessed and prioritized based on condition and vulnerability to failure. TRORC is continuing to work with communities to update their Hazard Mitigation Plans, work with town highway departments to be compliant with 2013 Town Road and Bridge Standards (including the desired culvert inventory to flag poorly performing culverts and integrate data into a capital improvement plan), and identify high risk road erosion areas for future projects. This grant opportunity will



cover a significant portion of our Region's member towns and improve regional resiliency. Please contact Rita Seto at rseto@trorc.org for more information.

## 2014 Better Back Roads Awards

TRORC has provided assistance in identifying priority locations for improving infrastructure resiliency and been able to find funding to assist towns for implementing projects. Congratulations to the following towns on their 2014 Better Backroads awards: Category A planning projects (Bethel, Braintree, Randolph, Stockbridge, Tunbridge and Woodstock); Category B construction projects (Corinth, Norwich).



Over \$40,000 worth of projects focusing on improving water quality and road erosion problems have been awarded to towns in the Two Rivers-Ottauquechee Region. Category A projects focus on road erosion inventories and capital budget planning (e.g. culvert inventories or identifying top road erosion sites). Category B projects focus on implementing a correction to the road related erosion problem (e.g. replacing an undersized culvert or stream bank stabilization).

These grant funds are provided by the Vermont Agency of Transportation and the Vermont Agency of Natural Resources. The Vermont Better Back Roads Program's goal is to promote the use of erosion control and maintenance techniques that save money while protecting infrastructure and enhancing water quality in Vermont's lakes and streams. #### TRORC participates in the Vermont Public Health Action Institute

The Action Institute, funded by the National Center for Chronic Disease Prevention and Health Promotion Partnerships to Improve Community Health (PICH), is a new 3-year initiative to improve health and reduce the burden of chronic diseases. Action teams created around the state will focus on Healthy Community Design. The teams include a variety of governmental agencies and non-governmental organizations, including local public health departments, to create environments that support health and healthy behaviors.

On July 30 and 31, Loralee Morrow of TRORC and Lee Krohn of Chittenden County Regional Planning Commission were asked to discuss regional planning commissions' role in supporting Healthy Community Design efforts. These efforts support the
