
What is a Corridor Plan?

What are we doing?



- Identify longer-term needs where more background work is needed first – such as a finding funding, developing partnerships, or doing more research to identify an appropriate solution.


Where do we get information?

- **Public** people and groups who use the corridor, including businesses, residents, and advocacy groups





Survey Results – Intersection Safety Improvements




- Question 4 Please select your top three intersections for safety improvements?

 - US-4 and Happy Valley Rd






