4. Acceptance of unaudited February Financial Reports

Everything is as expected, we had a little bit of delays in receiving funds, we have cleaned up those. Mary has been diligent with getting AR payments to us. We had a couple Vermont Community Loan letters come in with amounts earned in interest, which is reflected in the Interest Income Line. Scholarships are still trickling in and are awaiting a response from a few students. Commissioner Jones and Scholarship Committee stated that a new issue arose regarding the new format of schooling. One student was in a trimester and the scholarship committee decided to see the report of both 1st and 2nd trimester grades prior to releasing funds. The committee will continue to assess new issues as they arise.

Commissioner Echeverria asked if TRORF funds had been used for shared services. Not yet as staff capacity is not there.

On a motion by Commissioner Jones and seconded by Echeverria the unaudited February Financials were accepted.
