

PROJECT UPDATES AND REMINDERS

Hartland 3 Corners Intersection Project Substantially Complete

The Hartland 3 Corners intersection reconfiguration project is now complete! The intersection of US-5, VT-12, and Quechee Road was redesigned to become a four-way intersection with underground utilities and new sidewalks to improve safety and walkability in the village. TRORC Transportation Manager Rita Seto served as Municipal Project Manager, coordinating with Town officials, VTrans, VHB (design engineering firm), GPI (construction inspection firm) and Notts Excavating to complete the construction project. The Town is working with its utility providers (Green Mountain Power, Comcast, First Light, and VTeI) on the final phase of moving electric and telecom service underground before the intersection's two utility poles can finally be removed. TRORC Assists Pinney Hollow Brook Floodplain Restoration Project

TRORC and its partners recently finished the first half of the Pinney Hollow Brook floodplain restoration project in Plymouth. The upper site was a former motel that was bought out and demolished through a FEMA buyout administered by TRORC after Tropical Storm Irene. The project will help reduce the risk of erosion and washouts on adjacent Route-100A during flooding events. Funding was provided by VT Emergency Management through the **Flood Resilient Communities Fund**. Additional funding and monitoring were provided by VT Fish and Wildlife. Plantings on the site will be completed this spring by the Connecticut River Conservancy and more work will be completed this spring downstream. Stay tuned!

All 30 TRORC Towns Apply for Municipal Building Energy Audits through MERP; First Audits Performed in Topsham and Newbury Village

With assistance from TRORC staffers Harry Falconer and Jeff Grout, all 30 of the region's towns have applied to receive free municipal building energy audits from the state's **Municipal Energy Resilience Program (MERP)**.

Topsham Town Hall and Newbury Village's Bailey Club received the region's first audits on November 1st. More than half of the region's towns have been awarded at least one audit, with more awards still to come.

TRORC is coordinating site visits with with contractors and town officials. The site visits are expected to take place throughout the winter and into late spring of 2024. Several hundred audits will be awarded across the state.

MERP is a multiphase program that will culminate in the awarding of dozens of project implementation grants of up to \$500,000 each. Towns will apply for the Project grants to fund construction of the energy-efficiency retrofits suggested in their audit reports. Roughly 70 to 80 project grants are expected to be awarded statewide.

The MERP program is also offering **\$4,000 "mini-grants"** to help towns fund education and community engagement efforts about energy and climate resilience. The mini-grants are not competitive and thus will be awarded to any town that applies for an eligible use. So far, 19 of the region's towns (plus one incorporated village) have applied to claim their mini-grant funds. The towns that have <u>not</u> applied are: Braintree, Bridgewater, Brookfield, Chelsea, Corinth, Newbury, Rochester, Royalton, Stockbridge, Topsham, and Tunbridge. The mini-grant application remains open.

Downtown Board Approves Sharon Village Designation Renewal

On Monday October 23, 2023, the Vermont Downtown Board approved the Town of Sharon's Village Center Designation renewal application. The Village Center Designation process recognizes and encourages local efforts to revitalize Vermont's traditional villages. Once designated, the community receives priority consideration for state grants (Municipal Planning Grants, Vermont Community Development Program) and other resources and support. Commercial property owners are eligible for tax credits to support building improvements.

The Town of Sharon worked with TRORC staff to develop the renewal application for the program.

Bradford Installs New Electric Vehicle Fast-Charging Stations

The Bradford Energy Committee, with help from TRORC's Intermunicpal Regional Energy Coordinator Jeff Grout, recently completed the first phase of its <u>EV charging station project at a public parking lot on North Main Street</u> in the village center. Two fast-charging stations and a level-2 charging station are now in operation.

The project's second phase will take place in the spring of 2024, when additional stations will be installed. The charging infrastructure was provided by local energy firm Norwich Technologies. A planned grand opening celebration was postponed until spring due to inclement weather.

Important Reminder: Local ARPA Funds

With FY25 municipal budget planning already underway, now is the time to think about obligating your town's ARPA funds. A couple of key considerations:

- 1. Local ARPA funds must be obligated by December 31, 2024. Obligation means an order has been placed for goods or services or you have entered into a contract, subaward, or similar transaction that requires payment. If you are using ARPA funds to pay staff salaries or other internal costs, this needs to be documented with a resolution by the Selectboard.
- There is a lot of flexibility in how ARPA funds can be spent BUT THERE ARE ALSO SOME PROHIBITED EXPENDITURE CATEGORIES. If you don't feel confident in your knowledge of what's allowed, please contact <u>Sarah Wraight</u> ASAP.
- 3. If you don't think your town can obligate all its funds by December 31, 2024, OR if you can obligate but won't be able to spend the funds by December 31, 2026 (perhaps because of permitting timeframes and the fact that contractors are booking out several years in advance at this point), please contact <u>Sarah</u> <u>Wraight</u> ASAP to discuss your options.

TRORC Assists Six Towns in Preparing Municipal Planning Grant Applications

TRORC recently assisted six of the region's towns in applying for <u>Municipal Planning Grants (MPGs</u>) and <u>Bylaw</u> <u>Modernization Grants (BMGs</u>) from the Vermont Agency of Commerce and Community Development. MPGs can be used broadly to support many different types of local planning and revitalization efforts, while BMGs focus specifically on the modernization of local bylaws such as zoning codes. This year, Chelsea and Braintree opted to apply for BMGs, while Barnard, Corinth, Fairlee, and Strafford applied for MPGs. The towns that applied for MPGs ranged broadly in their desired uses of the funds, from capital budgeting to regulation of short-term rentals.

Awards are expected to be announced next month.

VOREC Community Grant Program

The VOREC Community Grant Program from the Vermont Outdoor Recreation Economic Collaborative (VOREC) and the Vermont Department of Forests, Parks and Recreation (FPR) will award up to \$6 million to communities around the state for outdoor recreation projects in four categories: Implementation, Project Development, Outdoor Equity and Flood Recovery.

Paul Bruhn Historic Revitalization Grants

"The Preservation Trust of Vermont is pleased to announce the opening of the 2024 <u>Paul Bruhn Historic</u> <u>Revitalization grant</u> round. PTV has \$625,000 available to preserve and restore buildings and community gathering spaces of economic and social significance in rural communities. Examples of work we support are roof repair or replacement, structural repairs, facade, window and door restoration or repair, code compliance work, and climate resiliency improvements. Grants will be made in increments of \$50,000-\$100,000."

Applications are due on December 21, 2023. Please note that properties must determine their National Register listing status in order to determine eligibility for the grant. <u>Visit PTV's website</u> for full details.

TRORC Brownfields Assessment Funding

As a reminder, TRORC has funding from the EPA to assess brownfield sites in the TRORC region, and has received \$1,600,000 over the past decade to perform petroleum and hazardous waste assessments. TRORC works closely with Vermont Department of Environmental Conservation staff to promote redevelopment of brownfields properties, including enrolling properties in Vermont's Brownfields Reuse and Environmental Liability Limitation Act (**BRELLA**) program.
